Brunet will distribute information. • Distracted driving is causing majority of the accidents. • Electronic logs expected June 2020. • A stakeholder's meeting is planned for June 2020 with a view to implementing changes by January 2021. Will be a meeting in Ottawa area for feedback.
8	<p>Workplace Safety & Insurance Board</p> <ul style="list-style-type: none"> • Safety Groups are being replaced by WSIB Health & Safety Excellence Program. Good for small companies. All will join for rebates. Companies will design audit and audit themselves.
9	<p>Ontario Regional Common Ground Alliance</p> <ul style="list-style-type: none"> • Can hire a dedicated locator – one locator assigned to your project and would do all of the locates. Incentive is that they are paid per metre after a certain amount. • Utilities pay Promark. • Direct Bore has an agreement with Promark. Depending on the project, can do locates in 150m sections. If working in row homes, may be reduced to 80m. • Dirt report is useful. • Private locates cost about \$115/hour. The locator would have to be approved by every utility. • Should have a different system for homeowners and contractors. • The system needs to be redefined and rebuilt.
10	<p>City of Ottawa</p> <p>Proposed Health and Safety Management System</p> <ul style="list-style-type: none"> • NCHCA should ensure that there is a support mechanism in place in Ottawa for each approved system. • Relay back to IHSA that the support has to be here. In Ottawa, if they do not have 60% they will cancel. They cancel 50% all the time. If we hear that they are not, we need to relay that to IHSA. <p>Other</p> <ul style="list-style-type: none"> • City is giving tickets for noise violations. • No more sound or air testing now. <p>NCHCA/City Liaison Meetings</p> <ul style="list-style-type: none"> • October 15, 2019 Liaison Meeting Notes were reviewed. • Next Liaison Meeting: December 13, 2019.
